## **OREGON STATE LOTTERY SPECIAL COMMISSION MEETING Jan. 10, 2025**

Chair Saathoff called the Jan. 10, 2025, Oregon State Lottery Special Commission meeting to order and stated for the record that the commissioners are attending the meeting via a web meeting, and a quorum of commissioners is present.

Director Wells shared that after an extensive recruitment process for the Assistant Director of Operations, he is excited to recommend the appointment of Charles “CJ” Green to the position. Director Wells added that Green has 24 years of experience in strategy, business development, and operational execution and believes that he will be an excellent addition to Lottery’s leadership team.
